Our office doors are currently open Monday - Friday, 9:00 a.m. - 3:00 p.m. Our in-house call center answers phones Monday - Thursday, 8:45 a.m. - 4:00 p.m., and Friday , 9:00 a.m. - 3:00 p.m. However, in the case of an emergency regarding any common areas within your community, we are available 24 hours a day, 7 days a week, by calling the same number and you will be prompted to reach our emergency call center representatives if after business hours. Naturally, if the emergency is a fire or threat of personal injury, power outage, etc. you should contact the appropriate local agency or call 911.

Monthly Assessments

Your assessment fee is always due on or before the first day of each month. Please keep in mind it is important that your fees are paid in a timely manner to ensure the smooth operation of your association and to avoid late charges and penalties.

Your next assessments for January (\$135) and February (\$135) are due February 1, 2024 for a total of \$270. Please make your payment by check payable to The Meadow at Parker Lakes Neighborhood Homeowners Association, Inc.. Your check can be mailed to or dropped off at the Alliant address above. If you have already sent in your payment for January, you may deduct that amount from your payment.

In the near future you should receive a coupon booklet from Western Alliance Bank to pay future assessments. Instructions for payment options will be outlined in the coupon booklet (check, ACH, credit card, bill pay, etc.).

ACH payments can be set up upon receipt of your coupon booklet. Please use this letter as a reference and utilize the directions below to set up your ACH:

- Go to the website for Western Alliance Bank: https://pay.allianceassociationbank.com/Home.
- Once you are on this page you will want to create a user ID by selecting the "Set-Up Account' green button in the middle of the page. It will ask for you to create a user with a password and security questions. Once this is complete it will bring you to a new screen.
- On the top of the screen you will see a selection "Set-up Scheduled Payments"; click on this. It will ask you to add a property, click on the "add property" tab. You will need the below information, once added you will push " add property", this will think your property to your profile.
 - Mgmt Company ID : 7811
 - Association ID: TMPL
 - Property Account Number: XXXXXXX (this will be provided in your booklet)

• Next you will select a payment method, the monthly amount for your property, and the date you want it to start (i.e., 3/1/24).
